

**NFL-NFLPA COVID-19 Testing Cadence for 2021 Regular Season**

Category of Individual	Testing Requirements
<p>Fully Vaccinated Individuals (Tier 1 (including players), Tier 2, Tier 2M, Tier 3 Individuals) - <b>Excludes Medical Professionals Not Present at Club Facility Each Day</b></p> <p><b>**“Fully Vaccinated” is defined in the NFL-NFLPA Protocols</b></p>	<p>These individuals must test <b>once every game week</b> via BRL PCR or the Mesa Test during weeks they are entering the Club facility. Individual does not need to wait for results to return prior to entering the Club facility. These tests must be conducted over a 3-day period at the Club facility.</p> <p><b>Re-Entry Testing After Bye Week or 3 or More Consecutive Days Off:</b> Any Tier 1/Tier 2 Individual, including players, who is <b>fully vaccinated</b> must undergo the following “Re-Entry” Testing prior to re-entering Club facility after the Club’s bye week or after 3 or more consecutive days off:</p> <ul style="list-style-type: none"> <li>• <b>Day 1:</b> BRL PCR Test and Mesa Test: May enter club facility once Mesa Test result returns negative.</li> </ul>
<p>Not “Fully Vaccinated” Tier 1 (including players) and Tier 2 Individuals</p>	<p><b>Pre-Entry Testing:</b> Tier 1 Individuals (including players) and Tier 2 Individuals who are <b>not fully vaccinated</b> and are entering the Club facility for the first time must undergo the following Entry Testing:</p> <ul style="list-style-type: none"> <li>• <b>Day 1:</b> Mesa Test and BRL PCR (may not enter Club facility until negative Mesa Test results return)</li> <li>• <b>Day 2 and Thereafter:</b> Mesa Test (may not enter Club facility until negative results return)</li> </ul> <p><b>Testing Thereafter:</b> Mesa Testing <b>Every Day</b> (may not enter Club facility until negative results return)</p> <p><b>Re-Entry Testing:</b> Any Tier 1/Tier 2 Individual, including players, who is <b>not fully vaccinated</b> who misses a day of testing must undergo the following “Re-Entry” Testing prior to re-entering Club facility:</p> <ul style="list-style-type: none"> <li>• <b>Day 1:</b> Mesa Test and BRL PCR Test (No entry to Club facility)</li> <li>• <b>Day 2:</b> Mesa Test (No entry to Club facility)</li> <li>• <b>Day 3:</b> Mesa Test (No entry to Club facility)</li> <li>• <b>Day 4:</b> Mesa Test (No entry to Club facility)</li> <li>• <b>Day 5:</b> Mesa Test: May enter Club facility once Day 5 Mesa Test results return negative.</li> </ul>
<p><b>Fully Vaccinated</b> Tryout/Street Free Agent Players; Acquired from Other Clubs (Waivers, Trade, Signed Off Another Club’s Practice Squad)</p>	<p><b>Pre-Entry Testing:</b> One Mesa Test taken on the date of entry to the Club facility for the first time. Player must wait for the test to return negative before entering.</p>

Category of Individual	Testing Requirements
<p><b>Not “Fully Vaccinated”</b> Tryout Players, Street Free Agent Players and Players Acquired from Other Clubs (Waivers, Trade or Signed Off Another Club’s Practice Squad)</p>	<p><b>Pre-Entry Testing:</b> These individuals must undergo the following testing before entering the Club facility to try out or join in-person team activities:</p> <p><b>Day 1:</b> Mesa Test (may not enter Club facility)  <b>Day 2:</b> Mesa Test (may not enter Club facility)  <b>Day 3:</b> Mesa Test (may not enter Club facility)  <b>Day 4:</b> Mesa Test (may not enter Club facility)  <b>Day 5:</b> Mesa Test (may not enter Club facility until Day 5 Mesa Test results negative).</p> <p>Such a player may not have any in-person contact with any players, or Tiered staff during the on-boarding period (until Day 5), except that such players may be permitted to undergo a physical examination at the Club physician’s office during this period.</p> <p>*Any player who is terminated and re-signed by the same Club and does not miss a test and does not leave the terminating Club’s city will not be required to undergo any additional testing before rejoining the Club</p>
<p>Not “Fully Vaccinated” Tier 3 Individuals</p>	<p><b>Pre-Entry Testing:</b> One negative Mesa Test prior to entering the Club facility for the first time on the date of entry (may not enter Club facility until negative results return).</p> <p><b>Testing Thereafter:</b> <b>Once per game week</b> (Mesa), on a day of the Club’s choosing, during weeks they are entering the Club facility (may not enter Club facility until negative results return). These individuals may not interact with Tier 1 or Tier 2 Individuals (including players) at any time.</p>
<p>Tier 3-OA Individuals</p>	<p><b>No Testing Required.</b></p>
<p>Medical Providers and Other Service Providers Not in the Club Facility on Daily Basis (e.g., chiropractors, massage therapists, barbers, etc.)</p>	<p><b>Pre-Entry Testing:</b> One Mesa Test taken on the date of entry to the Club facility each time. Individual must wait for the test to return negative before entering. *As set forth in September 8, 2021 Memo.</p>
<p>Drug &amp; Steroid Policy Collectors</p>	<p><b>Pre-Entry Testing:</b> All Substances of Abuse and/or Performance-Enhancing Substances Policy specimen collectors must be fully vaccinated in order to access any Club facility. They will need <b>one Mesa Test</b> taken on the date of entry to the Club facility each time. Individual must wait for the test to return negative before entering and must wear a mask at all times while in the Club facility.</p>
<p>NFLPA Reps/NFL Official Visitors</p>	<p><b>Pre-Entry Testing:</b> NFLPA Reps and NFL Official Visitors need <b>one Mesa Test</b> taken on the date of entry to the Club facility each time. Individual must wait for the test to return negative before entering.</p> <p>NFL and/or NFLPA representatives who are not fully vaccinated and enter the Club facility following a negative test may not enter the locker room, cafeteria, weight room or conduct/participate in meetings indoors in person.</p>
