

NFL Combine Sweepstakes ("Sweepstakes")

Official Rules

NO PURCHASE OR MOBILE APP NECESSARY TO ENTER OR WIN.

1. Eligibility: The Sweepstakes is open to legal permanent residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older. Employees, officers, directors, agents and representatives of NFL Properties, LLC ("Sponsor"), the other NFL Parties (the National Football League, its member professional football clubs, NFL Ventures, Inc., NFL Ventures, L.P., NFL Enterprises LLC, NFL International LLC, NFL Productions LLC and each of their respective affiliates, owners, subsidiaries, shareholders, officers, directors, partners, agents, representatives and employees, both individually and collectively) and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising and promotion agencies (hereafter collectively, "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. Void where prohibited by law. All applicable federal, state and local laws apply.

2. Promotion Period: The Sweepstakes begins at 12:00:00 am Eastern Time ("ET") on 2/23/22 and ends at 3pm ET on 3/6/22 (hereafter, "Promotion Period").

3. How to Participate: There are two (2) ways to participate during the Promotion Period:

Attend the NFL Combine: During the Promotion Period, entrants must visit <https://www.nfl.com/combine/tickets> and follow the instructions provided to register for one (1) or more ticket(s) to attend NFL Combine currently scheduled to take place from 3/3/22 to 3/6/22 at Lucas Oil Stadium. Upon scanning their ticket(s) at the stadium, entrants will receive one (1) entry.

Email: To receive one (1) entry without attending the NFL Combine, you may enter by sending an email to Experience.Support@NFL.com with subject line "NFL Combine Sweepstakes" inclusive of your complete name, address, city, state, zip, phone, and date of birth in the body of the email.

Entries must be received by 3:00 pm ET on 3/6/22. Limit one (1) entry per person throughout the Promotion Period, regardless of the method of entry. All entries become the exclusive property of the Sponsor and will not be acknowledged or returned. The use of script, macro or automated devices (or any other devices intended to automate or subvert any aspect of entry) to enter the Sweepstakes is prohibited and any entry through such means and any entry that is deemed to be ineligible (at Sponsor's sole discretion and in accordance with these Official Rules) are void. In the event of a dispute as to the identity of an entrant, such entrant will be deemed, as the "authorized account holder" of the email address submitted provided he/she is eligible according to these Official Rules. "Authorized account holder" is defined as the natural person who is assigned to the email address by an Internet access provider, online service provider or other organization (e.g., a business, educational institution, etc.) which is responsible for assigning email addresses for the domain associated with the submitted email address. Proof (to Sponsor's satisfaction) of being the authorized account holder may be required by Sponsor.

Released Parties are not responsible for late, lost, stolen, incomplete, misdirected, delayed, garbled, inaccurate, or undelivered emails, QR scans, Badges or entries, or for telephonic, human, electronic or computer failures, problems or errors, interruptions in service due to

system upgrades, repairs, modifications or other causes, failures or malfunctions of connections, electronics, satellite, network, cable, Internet Service Provider (ISP), phones, mobile, or other device (including wireless phones/handsets or other wireless devices), phone lines or telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by equipment, programming, human error or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of emails, QR scans, Badges or entries or the announcement of any prize; or for any injury or damage to entrant's or any other person's computer or wireless device relating to or resulting from participation in this Sweepstakes, or for printing, typographical, human or other errors appearing in these Official Rules or other Sweepstakes-related materials. 4. Winner Selection/Notification: At the conclusion of the Promotion Period, one (1) Grand Prize winner and one (1) First Prize winner will be randomly selected from among all eligible entries received throughout the Promotion Period. Drawing will be conducted by Sponsor on/about 8PM ET on 3/6/22. By entering, entrants agree to be bound by these Official Rules and to the decisions of the Sponsor and judges, which will be final and binding in all respects. The potential winners will be notified by telephone and/or email and will be required to complete an Affidavit of Eligibility, Liability and (where legal) Publicity Release and any other required documentation within two (2) hours of time of issuance of notification. Non-compliance with the foregoing or with these Official Rules or return of prize notification as non-deliverable may result in disqualification and, at Sponsor's discretion and time permitting, awarding of prize at hand to an alternate winner.

5. One (1) Grand Prize: A 4-day/3-night trip for winner and one (1) guest to Super Bowl LVII ("SBLVII") currently scheduled to take place on 2/12/23 in Glendale, AZ. Trip includes: i) round trip coach air transportation from a major gateway airport nearest winner's residence to a destination determined by Sponsor in its sole discretion; ii) one (1) standard hotel accommodation (one (1) room, double occupancy) for three (3) nights; iii) round trip ground transportation to and from the game; and iv) two (2) tickets to SBLVII. Approximate Retail Value ("ARV"): \$3,000. **One (1) First Prize:** A 4-day/3-night trip for winner and one (1) guest to the 2022 NFL Draft taking place in Las Vegas, NV April 28--30, 2022. Trip includes: i) round trip coach air transportation from a major gateway airport nearest winner's residence to a destination determined by Sponsor in its sole discretion; ii) one (1) standard hotel accommodation (one (1) room, double occupancy) for three (3) nights; and iii) two (2) tickets to the 2022 NFL Draft. ARV: \$2,000.

If winner resides within a one hundred fifty (150) mile radius of a destination city, ground transportation may be provided in lieu of air transportation at Sponsor's sole discretion, and no compensation or substitution will be provided for difference in prize value. Arbitration: Except where prohibited by law, as a condition of participating in this Sweepstakes, entrant agrees that (1) any and all disputes and causes of action arising out of or connected with this Sweepstakes, or the prizes awarded, shall be resolved individually, without resort to any form of class action, and exclusively by final and binding arbitration under the rules of the American Arbitration Association and held at the AAA regional office nearest the entrant; (2) the Federal Arbitration Act shall govern the interpretation, enforcement and all proceedings at such arbitration; and (3) judgment upon such arbitration award may be entered in any court having jurisdiction.
