

THE JULY INTERNATIONAL GAME SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM THE PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The July International Game Sweepstakes ("Sweepstakes") is sponsored by Comenity Servicing, LLC ("Sponsor"), 3095 Loyalty Circle, Columbus, OH 43219 and is administered by Clarus Commerce LLC dba ebbo, ("Administrator"), 500 Enterprise Drive, 2nd Floor, Rocky Hill, CT 06067.

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins on July 1, 2024 at 9:00 AM Eastern Time ("ET") and ends on July 15, 2024 at 11:59:59 PM ET ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes official clock.
- 2. ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States (including the District of Columbia) who are at least eighteen (18) years old at the time of entry. Employees of Sponsor, Administrator, the NFL Entities (as defined below) and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Sweepstakes Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

- 3. HOW TO ENTER:** There are four (4) ways to enter the Sweepstakes as outlined below:
 - A. Redeem Rewards Points or Enter Via Free Method:**
 - i. Redeem NFL Extra Points Visa® Credit Card or Green Bay Packers Extra Points Mastercard® Credit Card Rewards Points:** To enter the Sweepstakes by redeeming Rewards Points, an eligible entrant must have an open NFL Extra Points Visa® Credit Card or Green Bay Packers Extra Points Mastercard® Credit Card account. Cardholder must register their account within the online Account Center. Creating an account is free. If an entrant is not registered for Account Center then he/she must visit the Account Center website at comenity.net/nflvisa or comenity.net/greenbaymastercard and complete and submit the registration form, including, but not limited to: his/her first and complete last name (no initials), phone number, city, state, and agreement to the NFL Extra Points Loyalty Program Official Terms and Conditions. After registering an account and logging-in, an eligible entrant can redeem their Rewards Points for a Sweepstakes entry by taking the following steps:
 1. Go to Rewards and Benefits section
 2. Click Redeem Now button under 'Your Available Rewards'
 3. Select 'Rewards Marketplace' as your redemption option
 4. Agree to leave Account Center button

5. Select 'See Rewards' and choose 'Sweepstakes' from drop down

Eligible entrants may enter the Sweepstakes by redeeming Rewards Points as set forth in NFL Extra Points Program Terms and Conditions found here: <https://d.comenity.net/ac/nflvisa/public/home>, for Sweepstakes entries. **Two hundred and fifty (250) Rewards Points must be redeemed to receive one (1) Sweepstakes entry.** Upon redeeming two hundred and fifty (250) Rewards Points, entrant will receive one (1) entry into the Sweepstakes. An entrant can enter one (1) time per calendar day by redeeming Rewards Points.

- ii. **Mail-In Without Redeeming Points:** To earn a Sweepstakes entry without redeeming points, an entrant may hand-write his/her complete name (no initials), valid e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP code, telephone number, and date of birth (MM/DD/YYYY), on a 3½"x5" card ("Mail-In Entry") and mail it (in an outer mailing envelope) with sufficient postage to The July International Game Sweepstakes - Points AMOE, PO Box 290936, Wethersfield, CT 06129-0936. A Mail-In Entry is worth one (1) entry. An entrant may mail-in one (1) per day during the Sweepstakes Period. Following this method of entry, an entrant will receive one (1) entry into the Sweepstakes.

All Mail-In Entries must be postmarked by July 15, 2024 and received by July 27, 2024. Mail-In Entries must be legibly hand-written. Mechanical reproductions, postage-due, and Mail-In Entries sent in excess of the entry limits set forth below will not be accepted. Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries.

Limit: Regardless of method of entry, an entrant will receive no more than one (1) entry per day during the Sweepstakes Period for redeeming of points/points AMOE method of entry. A "day" is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET on a calendar day during the Sweepstakes Period, except on July 1, 2024 when a day is defined as starting at 9:00 AM ET and ending at 11:59:59 PM ET, and on July 15, 2024 when a day is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET.

B. Make A Purchase Or Enter Via Free Method:

- i. **Make A Purchase:** During the Sweepstakes Period, entrants who have an NFL Extra Points Visa® Credit Card or Green Bay Packers Extra Points Mastercard® Credit Card may make a purchase using his/her NFL Extra Points Visa Credit Card or Green Bay Packers Extra Points Mastercard® Credit Card of \$50.00 USD or more ("Qualifying Purchase") to earn one (1) Sweepstakes entry. Entrant may make one (1) Qualifying Purchase per calendar day and receive one (1) Sweepstakes entry per calendar day during the Sweepstakes Period. Cardholder must have registered their account within the Reward Marketplace prior to making a Qualifying Purchase for entry into the Sweepstakes using this method. Creating an account is free. If an entrant is not registered for Reward Marketplace then he/she must visit register at the Account Center website as set forth in Section 3Ai.
- ii. **Mail-In Without Making A Purchase:** To earn a Sweepstakes entry without making a purchase, an entrant may hand-write his/her complete name (no initials), valid e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP code, telephone number, and date of birth (MM/DD/YYYY), on a 3½"x5" card ("Mail-In Entry") and mail it

(in an outer mailing envelope) with sufficient postage to The July International Game Sweepstakes - Purchase AMOE, PO Box 290936, Wethersfield, CT 06129-0936. A Mail-In Entry is worth one (1) entry. An entrant may mail-in one (1) per day during the Sweepstakes Period. Following this method of entry, an entrant will receive one (1) entry into the Sweepstakes.

All Mail-In Entries must be postmarked by July 15, 2024 and received by July 27, 2024. Mail-In Entries must be legibly hand-written. Mechanical reproductions, postage-due, and Mail-In Entries sent in excess of the entry limits set forth below will not be accepted. Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries.

Limit: Regardless of method of entry, an entrant will receive no more than one (1) entry per day during the Sweepstakes Period for the purchase/free AMOE method of entry.

C. Enter Via X or Instagram: During the Sweepstakes Period, an entrant must follow the steps below to receive one (1) Sweepstakes entry via X or Instagram:

- i. Sign into his/her X or Instagram account (entrant may create an X or Instagram account for free if he/she does not already have one);

The content included in the entry will not be judged or used in any way to determine the winner. By entering the Sweepstakes, commenting on the Sponsor's Post, tagging @NFLExtraPoints, and using the hashtag "#NFLXPSweepstakes", entrant hereby agrees to be bound by these Official Rules. Entries will be deemed made by the authorized account holder of the X or Instagram account the entry is submitted from at the time of entry. The "authorized account holder" is the person who is assigned to the X account or Instagram by the online service provider. An entrant must have a non-private X account or Instagram account to enter the Sweepstakes and must be a follower of @NFLExtraPoints on the platform used to enter until August 30, 2024 for potential winner notification purposes to be eligible to win/claim the prize. If an entrant does not have a non-private X account, he/she can create one at no cost by visiting www.twitter.com. Please note that an entrant must agree to comply with the X Terms of Service (<https://twitter.com/tos/>) and Privacy Policy (<https://twitter.com/privacy>) (if entering using X) in order to participate in the Sweepstakes. Entrants may create an Instagram account at no cost by logging on to <http://instagram.com>. Creation of an Instagram account requires a contestant to agree to Instagram's Terms of Service and Privacy Policy, available at <http://instagram.com/about/legal/terms/> and <http://instagram.com/about/legal/privacy/>, respectively. Due to the way Instagram operate its services, entries from users with protected or private accounts (i.e., entrant has set his/her account so that only people the entrant has approved can view his or her updates) may not be received. If an entrant enters from his/her wireless phone, the entrant's

wireless service provider may charge the entrant. Entrants should consult their wireless-service providers regarding their pricing plans. Message and data rates may apply. This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with X or Instagram.

Entry Requirements: All Entries must comply with the following restrictions:

- Entry must comment on Sponsor's Post;
- Entry must tag @NFLExtraPoints;
- Entry must tag a friend who he/she likes to watch an NFL game with;
- Entry must contain the hashtag "#NFLXPSweepstakes";
- Entry must be an original work;
- Entry must be in English (except for commonly understood foreign words);
- Entry must comply with X terms of use located at <https://twitter.com/tos/> and/or Instagram terms of use located at: <http://instagram.com/about/legal/terms/>;
- Entry cannot have been published previously by any party other than the entrant;
- Entry must be suitable for publication (i.e., may not be obscene or indecent);
- Entry cannot contain trademarks, logos or trade dress owned by any third party, or advertise or promote any brand or product of any kind, other than the Sponsor's;
- Entry cannot contain copyrighted materials owned by others (including photographs, sculptures, paintings and other works of art or images);
- Entry cannot include the name, likeness, photograph, or other indicia identifying any person, living or dead, without written permission from that person;
- Entry cannot be sexually explicit or suggestive, violent or derogatory of any ethnic, racial, gender, religious, professional or age group;
- Entry cannot promote illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing), any activities that may appear unsafe or dangerous, or any particular political agenda or message;
- Entry cannot describe or depict any illegal activity or violation of any state or federal law;
- Entry must not include any personally identifiable information (full name, e-mail address, telephone number, etc.);
- Entry must not contain, facilitate, reference or use material that contains prohibited content which shall include, but is not limited to, content that promotes, suggests, or encourages:
 - gambling, including without limitation, any content related to online casinos, sports books, bingo or poker;
 - the use of prostitution, pornography, nudity, profanity or other adult content, or violence;
 - the taking up of arms against any person, government or entity or otherwise challenge or seek to overthrow any government;
- Entry must not contain any viruses, spyware, malware, or other malicious components that are designed to harm the functionality of a computer in any way.

If any entry fails to comply with any of these Entry Requirements or any other provisions of these Official Rules, at the Sponsor's sole discretion, Sponsor reserves the right to disqualify the entrant.

By participating in the Sweepstakes, entrant understands that he or she is providing his or her information to Sponsor and not X, Inc. ("X") or Instagram, Inc. ("Instagram"). Further, entrant specifically agrees to release X and Instagram from any and all liability associated

with this Sweepstakes. This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with X, Instagram, or any of their affiliates.

IMPORTANT: MESSAGE AND DATA RATES MAY APPLY IF AN ENTRANT ENTERS THIS SWEEPSTAKES ON HIS/HER MOBILE DEVICE. NOT ALL MOBILE TELEPHONE/WIRELESS PROVIDERS CARRY THE SERVICE NECESSARY TO PARTICIPATE IN THIS SWEEPSTAKES. ENTRANTS SHOULD CONSULT THEIR WIRELESS PROVIDER'S PRICING PLANS. LIMIT: There is a limit of one (1) entry per platform person during the entire Sweepstakes Period (one [1] via X and one [1] via Instagram). If an entrant enters more than one (1) time per platform, only the first entry will be included in the Sweepstakes.

For All Entries: If more than the permitted number of entries are received from the same person, telephone number, social media account, and/or e-mail address, the entries may, at the Sponsor's sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address, social media account, or multiple identities. If it is found or suspected that an entrant is using more than one e-mail address, social media account, or multiple identities to participate in the Sweepstakes, then that entrant, in Sponsor's sole discretion, may be disqualified and not be eligible to win the prize. Subsequent attempts made by the same individual to submit multiple entries by using multiple or false contact information, accounts or otherwise may result in the entrant being disqualified. Entries generated by a script, computer programs, macro, programmed, robotic or other automated means are void and may be disqualified. Entries that are in excess of the stated limits, incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost, late or misdirected, deceptive or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor's sole and absolute discretion. Entries submitted by entrants who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void.

4. **RANDOM DRAWING:** On or around July 29, 2024 the Administrator will randomly select one (1) potential winner from all eligible entries received. The winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

5. **PRIZE, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:**

A. **Prize (1):** The "Prize" is a four (4) day/three (3) night trip for two (2) people – the winner and one (1) guest) – to attend the winner's choice of only one (1) of the three (3) 2024 NFL 2024 London Games, currently scheduled to occur on or about October 6, 2024, October 13, 2024, and October 20, 2024. Prize includes round-trip coach class air transportation from a major commercial airport near winner's residence to London, England for winner and one (1) guest, three (3) nights standard hotel accommodations (single room/double occupancy), round trip ground transfers between the airport and hotel and stadium while in London, \$500 made payable to the winner via Chase QuickPay which may be used towards travel expenses, and two (2) tickets – to be used only by the winner and one (1) guest – to the winner's choice of either the October 6th, October 13th, or October 20th NFL London Game. Game is subject to availability. Seat locations are determined by Sponsor in its sole discretion. Only one (1) Prize will be available in the Sweepstakes. The ARV of the Prize is \$8,500. The actual value of the Prize may vary depending on the game selected and fluctuations in the face value of game

tickets by team/market. Any difference between the estimated ARV and the actual value of the Prize will not be awarded.

The guest must be at least 21 years of age or the minor child/ward of the winner.

Travel must be taken on dates specified by Sponsor. Winner and guest must travel on the same itinerary. Travel dates are subject to availability; blackout dates and other restrictions may apply. Winner and guest are responsible for having all necessary valid travel documents including passports with at least six (6) months validity left as of travel date. The winner and guest must be able to legally enter the United Kingdom and return to the United States. The winner and guest understand that there are inherent risks involved in travel and that these risks may be present before, during and after the trip. Sponsor is not responsible and will have no liability if the winner and/or his/her guest is for any reason not permitted to travel by the relevant airport authorities or misses a flight or other travel element.

Winner is responsible for all travel expenses not included herein, including airline baggage fees, gratuities, meals, and any other incidental costs or expenses related to participation in the Prize. Travel must be booked at least forty-five (45) days in advance. Guest of winner must sign and return a travel liability release before travel will be booked. Winner and his/her guest hereby acknowledges that Sponsor has not and will not obtain or provide travel insurance or any other form of insurance for any part of the Prize. No changes will be made to travel details once any element(s) of the travel arrangements have been booked, except at Sponsor's sole discretion. Winner will be required to provide a major credit card upon hotel check-in, and all in-room charges will be charged to the credit card. Any damage to the room will be the responsibility of the winner. Sponsor bears no responsibility if any event, element, or detail of the Prize is canceled, postponed, or becomes unavailable for any reason. Should any event, element, or detail of the Prize become unavailable, the Sponsor shall have no obligation to the winner aside from providing the remaining portion of the Prize, minus any unavailable event, element, or detail.

Winner will not receive compensation from Sponsor for tickets that the winner is unable to use due to cancellation of the event, but tickets may be subject to standard rain-check policies and procedures set by the issuer. Winner agrees that game admission is awarded pursuant to a revocable, nontransferable license that is personal to that applicable winner, and may not be sold, resold, auctioned, bartered, assigned, exchanged, placed in commerce, transferred, given away, donated, or otherwise conveyed. Sponsor reserves the right to remove or to deny entry to winner and/or his/her guest if either winner or his/her guest violates the previous restrictions or engages in a disruptive manner, or with intent to abuse, threaten or harass any other person at the game.

If a winner cannot be confirmed by August 31, 2024 then the Prize may be unawarded in the Sponsor's sole discretion.

- B. Odds of Winning:** The odds of winning the Prize depend on the number of eligible Sweepstakes entries received during the Sweepstakes Period.
- C. General Conditions:** In no event will more than one (1) Prize, be awarded. If, for any reason, more than one (1) Prize notification is sent (or more than one [1] claim is received), Sponsor reserves the right to award the Prize through a random drawing from among all

eligible Prize claims received.

Sponsor bears no responsibility if any event, element, or detail of the Prize is canceled, postponed, or becomes unavailable for any reason, including, but not limited to, federal, state and/or local laws, rules and restrictions or NFL rules and regulations due to the COVID-19 pandemic. The winner and guest agrees that he/she will participate in all COVID-19 protocols established by the Sponsor and the host of the game, which may include, but is not limited to, social distancing measures, wearing of masks, submitting a COVID-19 waiver, and/or consenting to COVID-19 screening. The Sponsor will have no liability and will not be required to award a prize if a winner or guest tests positive for COVID-19, is unwilling or unable to participate in the screening or other protocols.

Participant irrevocably waives all claims against the National Football League, its member professional football clubs, NFL Ventures, Inc., NFL Ventures, L.P., NFL Properties LLC, NFL Enterprises LLC and each of their respective subsidiaries, affiliates, shareholders, officers, directors, agents, representatives and employees (collectively, the "NFL Entities") and agrees that the NFL Entities will have no liability or responsibility for any claim arising in connection with participation in this Sweepstakes or the prizes awarded. The NFL Entities have not offered or sponsored this Sweepstakes in any way.

- 6. HOW TO CLAIM THE PRIZE:** The potential winner is subject to verification of eligibility and compliance with these Official Rules. After the random drawing, Administrator will notify the potential winner via e-mail at the e-mail address provided at the time of registration or on either X or Instagram by a Direct Message from @NFLExtraPoints (depending on his/her method of entry) with instructions on how to claim the Prize. If notified on X or Instagram, the potential winner must respond to X/Instagram Direct Message winner notification within twenty-four (24) hours or they may, at the Sponsor's sole discretion, be disqualified. The potential winner will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within five (5) calendar days from the date of attempted notification or the Prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor's sole and absolute discretion. Failure to provide all required information and signed documents within the stated time period may result in forfeiture of winner's right to claim a Prize and may result in the Prize being awarded to an alternate winner, if time permits. If the potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, declines to accept the Prize, the Prize may be forfeited. If the Prize is forfeited, the Prize may be awarded to an alternate winner, selected in a random drawing from among all remaining eligible entries, as determined by Sponsor in its sole discretion. If, after a good-faith attempt, Sponsor is unable to award or deliver the Prize, the Prize may not be re-awarded. Upon verification of eligibility, the winner will be contacted to book travel arrangements for the Prize. Any portion of the Prize not accepted by winner will be forfeited. The winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for his/her Prize won. Sponsor will issue an IRS Form 1099-MISC to the winner. All other costs and expenses not expressly set forth herein shall be solely the winner's responsibility. The Prize will only be awarded to a verified winner.

Sponsor will attempt to notify the potential winner as set forth above, but Sponsor is not responsible for any undelivered e-mails or Direct Messages, including without limitation e-mails or Direct Messages that are not received because of the winner's privacy or spam filter settings which may divert any Sweepstakes e-mail, including any winner notification e-mail, to a spam or junk folder. Prizes that are unclaimed, unredeemed, or returned as undeliverable

will not be awarded. Prize is non-transferable and no Prize substitution, exchange or cash equivalent will be allowed, except by Sponsor, who reserves the right to substitute the Prize of equal or greater value in case of unavailability of the Prize or force majeure, at Sponsor's sole and absolute discretion. Sweepstakes Entities shall not be held responsible for any delays in awarding the Prize for any reason.

LIMITATION OF LIABILITY:** By participating in this Sweepstakes, entrants agree that the Sweepstakes Entities, X, Instagram, and each of their respective affiliates, subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers and each their respective officers, directors, stockholders, employees, representatives, designees and agents, Instagram, Inc., and X, Inc., ("Released Parties") are not responsible for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail/text notifications or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes; (vii) any injury or damage, whether personal or property, to entrants or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting the Prize (including any travel/activity related thereto); and (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. Further, the Sweepstakes Entities are not responsible for any unanswered or undeliverable winner notifications.

In no event will more Prizes be awarded than are stated in these Official Rules. In the event that, due to technical,

typographical, mechanical, administrative, printing, production, computer or other errors, there are more winners than are stated in these Official Rules, a random drawing among the claimants will be held to determine the winner.
