2024 NFL Draft Sweepstakes ("Sweepstakes")

Official Rules NO PURCHASE OR MOBILE APP NECESSARY TO ENTER OR WIN.

- 1. Eligibility: The Sweepstakes is open to legal permanent residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older. - **4. How to Participate:** There are two (2) ways to participate during the Promotion Period:

On-Site using eVoucher: Obtain an NFL eVoucher (QR code) (hereafter, "eVoucher") at no cost in one (1) of the following four (4) ways:

- 1) Any time during the Pre-Registration Period, visit www.nfl.com/draftaccess and follow the prompts to complete and submit the registration form. eVouchers will immediately be sent to entrant via e-mail or text message as specified by entrant during the registration process. Such entrants will be required to bring their eVoucher with them (either the printout form or the electronic version) to the NFL Draft Experience (hereafter, "Event") during the Promotion Period; OR
- 2) You may also register and receive an eVoucher using your OnePass mobile app at any time during the Pre-Registration Period. If you do not already have the OnePass mobile app on your device, you can visit the App Store and download the app (message and data rates may apply for app download and use) for free.
- 3) During the Promotion Period, see any NFL Brand Ambassador at the NFL Booth in the Event and provide the required registration information to the NFL Brand Ambassador who will submit the registration form on entrants' behalf. Upon completion, eVouchers will immediately be sent to entrant via e-mail or text message as specified by entrant during the registration process; OR
- 4) To receive an eVoucher without visiting www.nfl.com/OnePass or using a personal mobile device, see any NFL Brand Ambassador at the NFL Booth in the Event during the Promotion Period and complete and submit the registration form using the device provided by Sponsor. Upon completion, an NFL Brand Ambassador will hand a physical card containing an eVoucher (while supplies last). The availability to access an NFL Brand Ambassador, a device and/or submit a registration form or receive an eVoucher will be on a first-come, first-serve basis and Sponsor does not guarantee the availability or the opportunity to submit a registration form or receive an eVoucher.

Message and data rates may apply for those obtaining their eVoucher via methods 1 or 2 above. See your wireless provider for mobile device capabilities and fees.

THEN, visit any participating booth at the Event during the Promotion Period and follow the prompts to scan the eVoucher and follow any additional instructions provided to receive one (1) check-in (hereafter, "Check-in"). The total number of Check-ins will determine the Check-in prize drawing(s) ("Check-in Drawing") each entrant is eligible for as indicated in the below chart. For example, if an entrant obtains ten (10) check-ins throughout the Promotion Period he/she will be eligible for all five (5) random drawings (including the Grand Prize drawing).
